1. Online Course Provider
 - 1.1. Online Bible School (OBS) is provided by Capernwray Torchbearers Australia a member of Torchbearers International
2. Purchasing and Confirmation
 - 2.1. In order to purchase an OBS Topic, you must provide the required information and pay the amount specified. You must ensure that all information provided is complete and accurate.
 - 2.2. When you place an order for an OBS Topic you are agreeing to the terms of use set out in this document
 - 2.3. A legal binding agreement shall only come into place once Capernwray Torchbearers Australia has received the full funds for the Topic selected.
 - 2.4. Where you order multiple OBS Topics, each individual OBS Topic will be treated as a separate agreement.
 - 2.5. Before a contract comes into existence between you and us, we reserve the right to increase or decrease the advertised Topic Fee and/or amend any information contained in the OBS Topic description. We also reserve the right to withdraw at any time OBS Topics advertised for sale on the Website.
3. Payment
 - 3.1. The fee for any OBS Topic at any given time will be displayed on the website and or will be notified to you by Capernwray Torchbearers Australia.
 - 3.2. All amounts are payable in Australian Dollars. The prices quoted are inclusive of GST. Any currency conversion costs or other charges incurred in making payment shall be borne by you.

4. Transfer
